RESOLUTION 2020-07-14**

**A RESOLUTION DIRECTING THAT THE TOWN OF GRANBY COORDINATE THE
TOWN'S REGULAR ELECTION WITH THE GRAND COUNTY CLERK AND RECORDER**

WHEREAS, the Board of Trustees of the Town of Granby, Colorado, pursuant to Colorado statute, is vested with the authority of administering the affairs of the Town of Granby, Colorado (“the Town”); and

WHEREAS, during an election held on November 6, 2018, the voters of the Town of Granby, Colorado voted to move the Town’s regular elections to the first Tuesday after the first Monday of November of even numbered years; and

WHEREAS, the Town is required to enter into an agreement with the Grand County Clerk, who would conduct a coordinated election including the Town, substantially reducing the burden on Town staff and likely resulting in cost savings to the Town; and

WHEREAS, the Town Clerk has consulted with the Grand County Clerk and confirmed that, subject to the Town and the County entering into an acceptable intergovernmental agreement and/or other necessary documentation, the County Clerk is willing and able to conduct a coordinated election on November 3, 2020, that would include the Town’s regular election.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF GRANBY, COLORADO AS FOLLOWS:

1. The Town Clerk is hereby designated as the Town’s Election Official.
2. As the Town’s Election Official, the Town Clerk is hereby authorized and directed to take all steps she deems necessary or reasonable to facilitate and implement conducting the Town’s November 2020 election as a coordinated election through the Grand County Clerk.
