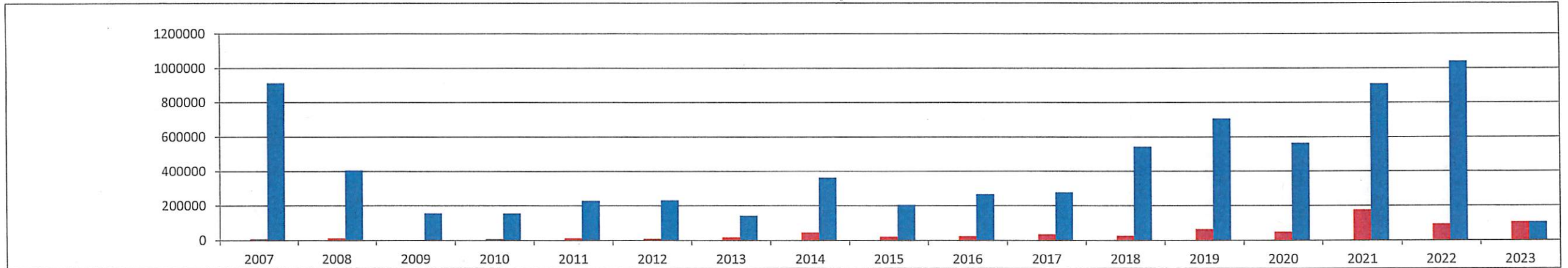

2023: 2023 ytd shows an increase of \$11,868 from 2022 or 13% more. It is 13% of the budget with 34% of the year elapsed. Three months of Motor Vehicle tax has been received. Motor Vehicle use tax is \$108,134 or 103% of the total use tax received. A refund was given from 2022 of \$8,098 (atypical). Revenue sharing was \$0 of the \$240,000 budget allocated to use tax.

2022: 2022 preliminary shows an increase of \$132,267 over 2021 or 14% more. 2022 is more than any other year on this chart. It was 149% of the budget.

Motor Vehicle use tax is \$356,476 or 35% of the total use tax received. Revenue sharing was \$201,266 of the \$240,000 budget allocated to use tax.

2021, the year ended 162% more than 2020, or \$344,984. Motor vehicles tax is \$286,745 or 32% of the total use tax for 2021.

Use tax is already 234% of the budget. Revenue sharing for use tax for 2021 was \$133,297.15, under budget but sales tax over.
