PEDDLERS, MOBILE VENDORS AND SOLICITORS LICENSE

Section 5.05.040 Administrative fees.

For a peddler, a solicitor, mobile vendor and a canvasser, the license fees will be as follows:

- _____ \$25.00 for a one (1) day license
- _____ \$50.00 for a seven (7) day license
- _____ \$75.00 for a one (1) month license, available only for mobile food vendor
- _____ \$350.00 for a six (6) month license, available only for mobile food vendor
- _____ \$500.00 for a one (1) year license, available only for mobile food vendor

An applicant, who is granted a one (1) month license, may apply for up to three (3) renewals of such license without submitting a new application for such renewals, provided that during the preceding term of the license, the Town has not received any written complaints regarding the license.
